PAVO offers support, *advice on best practice and partnership* to organisations that wish to develop their involvement of people and communities:

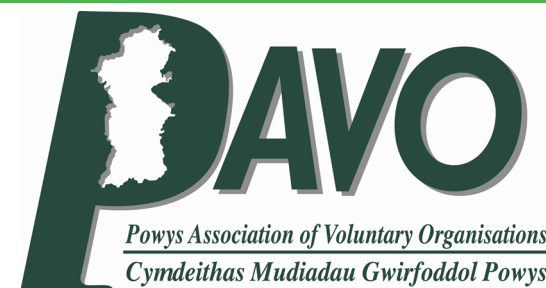
Facilitation: PAVO has accredited staff trained in public engagement.

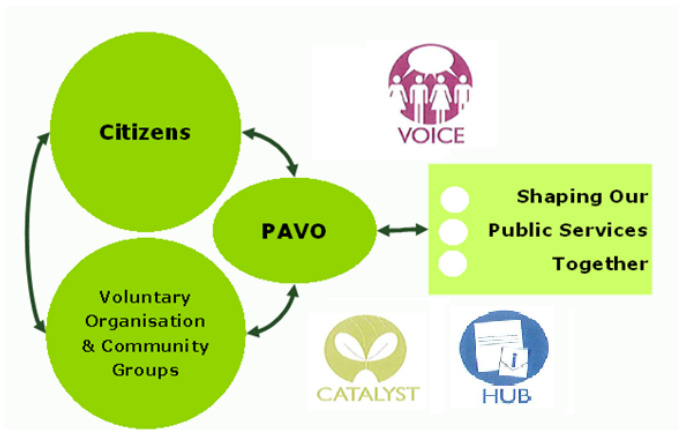

One of PAVO's three strategic purposes is to provide a VOICE for voluntary organisations and community groups and citizens so:

- their views are heard and influence policy development, service planning and delivery
- citizens' views and experiences are heard, understood and influence decision makers.

Strategy & Decision Making

PAVO represents the voice of the third sector on a number of strategic partnerships and decision making bodies, for example:

Local Service Board

Children & Young People's Partnership

Community Safety Partnership

Mental Health Planning & Development Partnership

Improving Patient Involvement & Experience

PAVO recruits and supports third sector representatives to decision making bodies where required.

PAVO's Chief Officer is the participation champion on the Local Service Board and chairs a Consultation & Engagement Officers Network (CEON) that oversees the implementation of the Powys Participation Strategy.



The People's Voice

PAVO supports individuals to have their say about matters that affect their lives and to influence decisions.

Mental Health Stronger in Partnership and Powys Patients' Council

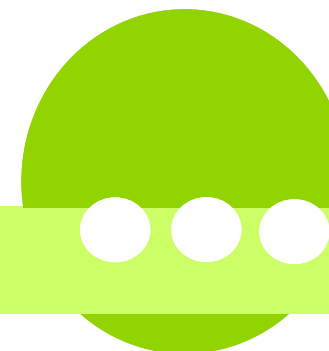
Community Development [working with groups of people in communities across Powys]

PAVO coordinates a Lottery Funded project, **Community Voice**, that supports organisations to enable the voice of the rarely and never heard. These organisations support carers, young people, older people and those suffering from neurological conditions and mental distress.

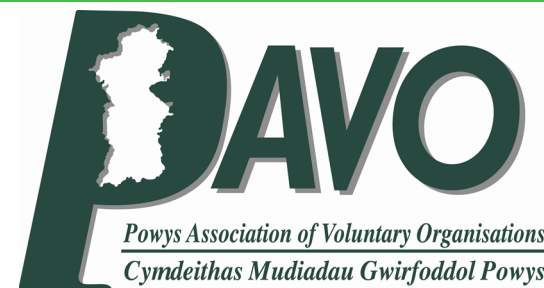

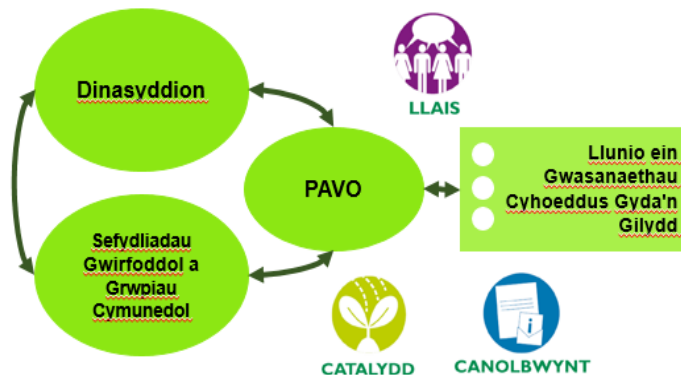
